- Have provided leadership in volunteer services within United Way as well as serving within their rank & file.
- Have contributed to the voluntary system of human services.
- Displayed creativity in devising new and better ways of performing volunteer assignments or in meeting community needs.
- Have had tangible and demonstrative impact in some form of service to their fellow citizen.
- Have been inspirational in their activities and qualities of performance have stimulated others to achieve greater service.
- Have sustained their service over a period of years, not necessarily in one post or organization.

Special consideration will be given Local Unions who have:

From time to time Local Unions are presented with opportunities to adventure above and beyond the normal call of duty. Whether your local union has collectively assisted a family in their time of need or have assisted a local community organization. We want to hear from you! Special Note

The committee wishes to stress the following points to Local Unions when making your nomination

- The Labour Community Award Service is highly competitive. It is vitally important when making your nomination that there is a complete and detailed account of your nominee's involvement in community affairs. To do this, you may have to approach the nominee (recommended) for further information. The committee does not accept verbal additions to the information provided in the selection process. In choosing a candidate, the committee will base their decision on the written information provided.
- The basic criteria for the award is involvement in local community affairs. Holding a position (past or present) within a local union or United Way is a consideration only. However, a member involved within both organizations will be given preference along with other community related activities.
- Your local should put forward its best candidate for the final selection process. However you are not limited to one nominee in either category (Builder or Current) if your local feels that it has a number of nominees of equal merit.
- While Union officials, full or part time, are not excluded from the award, and may be given equal consideration, the committee is hopeful that local unions do not ignore their rank and file membership when searching for nominees.
