



THE PROCESS IS SIMPLE

1. Complete the Notification of Securities Transfer Form (on reverse) and send it to United Way by email (steve@uwock.ca) or by fax (226-270-5535, Attention: Steve Pratt).
2. Instruct your broker to transfer your securities to United Way's brokerage account. Please do not transfer securities without first forwarding this form to United Way.
3. A charitable tax receipt will be issued for the closing price of the securities on the day of the transfer to United Way. All securities are sold on the same day as received by United Way.

THE BENEFITS ARE CLEAR

If you SELL a security, you pay tax on 50% of the capital gain.

However, when you DONATE a gift of securities to United Way of Chatham-Kent the taxable capital gain is completely eliminated

AND

You receive a tax receipt for the full market value of the security in the amount of the closing trading price on the day United Way of Chatham-Kent receives the security.

This multiplies the impact of the tax benefit of your charitable giving →

An example of the tax benefit of donating Gifts of Securities to United Way:		
	SELL security and	DONATE security
Market value of security	\$10,000	\$10,000
Cost base	\$5,000	\$5,000
Capital gain	\$5,000	\$5,000
Taxable capital gain (50%)	\$2,500	\$0
Tax due on gain at 46%*	\$1,150	\$0
Tax receipt for gift	\$10,000	\$10,000
Value of tax receipt at 46%*	\$4,600	\$4,600
Net tax savings	\$3,450	\$4,600
